in consideration of Five Hundred (\$500.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

unto Isabelle S. Brannon, her heirs and assigns, forever:

ALL that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Grove Township, known and designated as Lot No. 4 on a Plat of the property of W. E. Perry prepared by R. K. Campbell, in March 1962, entitled "Final Plat Reedy Acres", duly recorded in the R. M. C. Office for Greenville County, South Carolina, and having according to said plat, the following courses and distances to-wit:

BEGINNING at an iron pin in the Western edge of the Fork Shoals Road, joint front corner with Lot No. 3, and running thence with the joint line of said Lot No. 3 S. 71-05 W. 200 feet to an iron pin, back joint corner with said Lot No. 3 on line of Lot No. 10; thence with the joint line of said Lot No. 10 S. 19-34 E. 87 feet to an iron pin, joint back corner with Lot No. 5; thence with the joint line of said Lot No. 5 N. 71-05 E. 200 feet to an iron pin in the Western edge of the Fork Shoals Road, joint front corner with said Lot. No. 5; thence with the Western edge of said Fork Shoals Road N. 19-34 W. 87 feet to an iron pin the point of beginning, and bounded by Fork Shoals Road, other lands of the Grantor, T. Walter Brashier, and Lot. No. 5 this day conveyed to Anderson Durant.
