Inez Prince Burns, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, her heirs and assigns,

ALL that piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina on the east side of Buncombe Road and having the following metes and bounds, to-wit:

BEGINNING at an iron pin which is on Hawkins line, and is twenty-four (24) feet from stone 3x, that is now or was formerly joint 3x of Hawkins, Hudson and Malinda E. Burns' land, and runs thence, continuing along Hawkins line, S. 75-15 W. 350 feet to an iron pin on east side of Buncombe Road right-of-way; thence along said Buncombe Road right-of-way, S. 7-0 E. 125 feet to an iron pin on said right-of-way; thence N. 75-15 E. 350 feet to an iron pin in field; thence N. 7-0 W. 125 feet to the beginning 3x and contains one acre, more or less.

This is the same property conveyed to George G. Burns by deed dated February 28, 1938 which deed is recorded in the Office of the R.M.C. for Greenville County in Deed Book 202, at Page 200. George G. Burns died testate June 22, 1946 and devised the above described property to the Grantee herein. See Apartment 13, File 25 in the Office of the Probate Court for Greenville County. Grantee agrees and assumes to pay that certain mortgage covering the above described property to First Federal Savings and Loan Association in the face amount of \$2,500.00 dated January 28, 1966 and recorded in the Office of the R.M.C. for Greenville County in R.E.M. Book 1021, at Page 190, the amount due on which is \$1,953.85.

Also, this is the same property conveyed to the Grantor herein by deed of Inez Prince Burns, by deed dated June 15, 1967; and recorded in the Office of the R.M.C. for Greenville County, South Carolina in Deed Book 821 at Page 607.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining; TO HAVE AND TO HOLD all and singular the said premises before mentioned unto the Grantee and Grantee's Heirs/Successors and Assigns forever. AND Grantor does hereby bind Grantor and Grantor's Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto Grantee and Grantee's Heirs/Successors and Assigns against Grantor and Grantor's Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
