the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto  
Ernest L. Noles, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 80, Section 5, of a Subdivision known as Colonial Hills, as shown on a plat thereof prepared by Piedmont Engineers & Architects, dated October 18, 1966, recorded in the R. M. C. Office for Greenville County in Plat Book QQQ, at Page 21, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Fairford Circle, joint front corner of Lots Nos. 79 and 80, and running thence with the joint line of said lots, N. 88-29 W. 175.6 feet to an iron pin; thence N. 1-16 E. 89.75 feet to an iron pin, joint rear corner of Lots Nos. 80 and 81; thence with the joint line of said lots, S. 88-29 E. 175.9 feet to an iron pin on the western side of Fairford Circle; thence with the western side of Fairford Circle, S. 1-31 W. 90 feet to the beginning corner; being the same conveyed to me by Williams Land Company, Inc. by deed dated March 11, 1969, and recorded in the R. M. C. Office for Greenville County.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.

The grantee herein expressly assumes and agrees to pay the balance due on a certain note and mortgage executed by the grantor on March 14, 1969 in the original sum of \$ 14,500.00 in favor of First Federal Savings and Loan Association of Greenville, recorded in the R. M. C. Office for Greenville County in Mortgage Book 1120, at Page 92, on which there is a balance due of \$ 12,000.00 as of this date.

The restrictions affecting the above described property are recorded in the R. M. C. Office for Greenville County in Deed Vol. 825, at Page 561.
