ALL those certain pieces, parcels, or lots of land, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Holly Road near the City of Greenville, being shown as Lot # 4 on plat of EDWARDS FOREST HEIGHTS recorded in Plat Book 000 at page 89, and more fully described as follows:

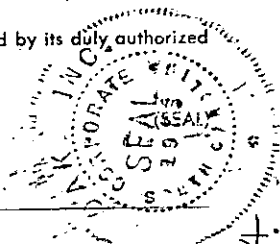
