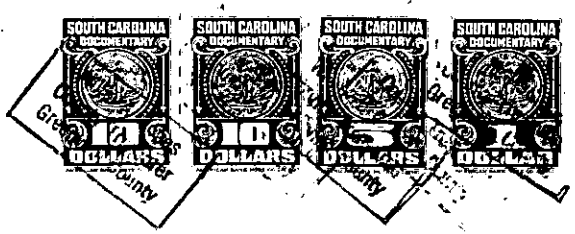
KNOW ALL MEN BY THESE PRESENTS, that Walter D. Rackley -----
