KNOW ALL MEN BY THESE PRESENTS, that JAMES W. MAHON,

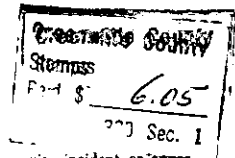
in consideration of FIVE THOUSAND THREE HUNDRED FIFTY-FIVE AND NO/100THS - - - Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto JAMES RAY GREER AND WILMA JANE GREER, their heirs and assigns:

ALL that certain piece, parcel or lot of land situate, lying and being in Grove Township, Greenville County, South Carolina, designated as Lot No. 19, Section No. 1, on a revised plat of Belle Terre Acres, dated August 29, 1967, recorded in the R. M. C. Office for Greenville County in Plat Book 000 at Page 106, said lot containing 2.5 acres, more or less, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the eastern side of East Fairway Drive at the joint front corner with Lot No. 20, and running thence along East Fairway Drive N. 7-50 W. 113 feet to an iron pin; thence N. 15-59 W. 68.4 feet to an iron pin at the corner of Lot No. 18; thence N. 53-12 E. 48.9 feet to an iron pin; thence N. 88-24 E. 516.7 feet to the center of Grove Creek; thence along said creek as the line S. 22-14 W. 270.9 feet to a point in said creek; thence along the line of Lot No. 20 N. 86-00 W. 420 feet to the point of beginning.

This being a portion of the property conveyed to the grantor by a certain deed recorded in the R. M. C. Office for Greenville County in Deed Book 459 at Page 528. The grantor to pay the 1969 County taxes on said property. This property is subject to the protective covenants recorded in the R. M. C. Office for Greenville County in Deed Book 711 at Page 181, and Deed Book 761 at Page 77, and as amended in Deed Book 822 at Page 508. In addition thereto, no goats, pigs or chickens shall be kept, produced or raised on said property.

This conveyance is further subject to easements and rights-of-way that may appear of record, on the recorded plat(s) or on the premises.
