KNOW ALL MEN BY THESE PRESENTS, that I, Eugene Cureton

in consideration of One Dollar (\$1.00) Dollars,
And Love And Affection
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Hoover Cureton, His Heirs And Assigns,

ALL that certain piece, parcel or tract of land, situate, lying and being in Austin Township, Greenville County, State of South Carolina, on the west side of Cureton Road, containing .93 Acres more or less, and having the following metes and bounds according to a survey made by W. J. Riddle, Surveyor, March 17, 1952 to wit:

BEGINNING at iron pin in the center of the Cureton Road at corner of the property of Jimmie Bates and running thence with the line of Jimmie Bates property S. 59-30 W. 579 Feet, more or less, to a stake at corner of S. A. Cureton property; thence with line of Cureton property, N. 2-30 W. 79.2 Feet to a stake; thence N. 59-27 E. 574.5 Feet, more or less, to a point in the center of the Cureton Road; thence along the center of said road, S. 5-20 E. 77.7 feet to the beginning corner.

ALSO, all that certain piece, parcel or tract of land situate in the County of Greenville, State of South Carolina, in Austin Township on the west side of Cureton Road, containing .92 acres, more or less, and having the following metes and bounds to wit:

BEGINNING at a point in the center of said Cureton Road at the southeast corner of the tract of land belonging to Charles Abercrombie and running thence along the center of said road S. 5-20 E. 77.7 feet; thence S. 59-27 W. 574.5 feet to a stake in line of S. A. Cureton property; thence N. 2-30 W. 79.2 feet to a stake, corner of Abercrombie property; thence with line of last mentioned property N. 59-24 E. 570 feet to beginning corner.
