All of that certain piece, parcel or lot of land with the buildings and improvements thereon on the Old Rutherford Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as a portion of the property of T.L. Clayton, plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book FF at page 298, and having according to a plat and survey made by R.K. Campbell, R.L.S. April 22, 1965, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Old Rutherford Road, at the corner of property now or formerly of Dwight L. Bragg, said pin being 659 feet in a southerly direction from the intersection of the Old Rutherford Road and Forest Hill Drive, and running thence along Bragg property, S. 88-0 E. 516.1 feet to an iron pin; thence S. 23-0 E. 126.4 feet to an iron pin; thence S. 59-50 W. 456.5 feet to an iron pin on the Old Rutherford Road; thence along the Old Rutherford Road, N. 24-47 W. 400.6 feet to the point of beginning.

As part of the consideration for the within conveyance the grantee assumes that mortgage on the above described real estate given by Carl F. Berry and Elizabeth D. Berry, which mortgage is recorded in the R.M.C. Office for Greenville County in Mortgage Book 1038 at page 57, with balance due thereon in the sum of \$16,663.33; said mortgage being payable to Aiken Loan & Security Company.
