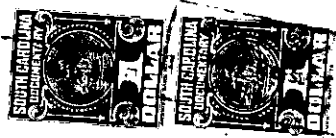
That I, Loyd E. Bryant in the State aforesaid. in consideration of the sum of SIX HUNDRED (\$600.00)----- DOLLARS,
