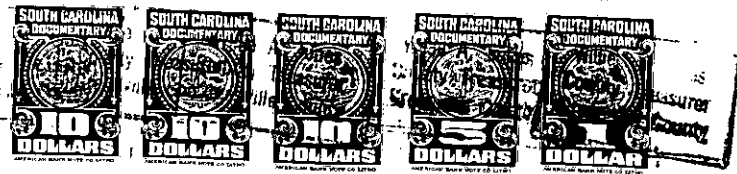
in consideration of Seventeen Thousand Nine Hundred Fifty (\$17,950.00) Dollars,

All that certain piece, parcel or lot of land situate lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 7 of a subdivision of the property of Lanco, Inc. as shown on plat prepared by R. K. Campbell and Webb Surveying & Mapping Co. October 1963, and recorded in the RMC Office for Greenville County in Plat Book RR at page 199 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern edge of Dunlap Drive, joint front corner of Lots Nos. 6 and 7 and running thence along the joint line of said lots, N. 34-56 E. 131.3 feet to an iron pin; thence S. 57-24 E. 175.4 feet to an iron pin at the rear corner of Lot No. 8; thence along the line of that lot S. 74-56 W. 198.8 feet to an iron pin on the northeastern edge of Dunlap Drive; thence along the northeastern edge of Dunlap Drive, following the curvature thereof, the chord being N. 39-05 W. 49.3 feet to the beginning corner.

This is the same lot conveyed to grantor by Ward S. Stone by deed recorded in the RMC Office for Greenville County in vol. 871 page 488, and is conveyed subject to restrictions recorded in deed vol. 771 page 223 and to utility and drainage easements of record.
