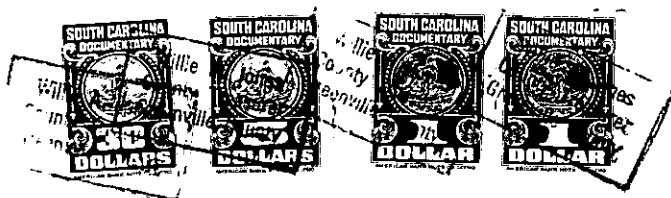
in consideration of Eighteen-Thousand Two-Hundred and no/100 (\$18,200.00) Dollars,

ALL THAT CERTAIN piece, parcel or lot of land lying and being situate on the West side of Duvernet Drive, near the City of Greenville, in the County and State aforesaid, being shown as Lot No. 37 on Plat of Section A of Plainsfield Park, made by Piedmont Engineering Service, December, 1960, revised June, 1962, recorded in the R. M. C. Office for said County in Plat Book XX at page 53, and having, according to said plat, the following metes and bounds, to-wit:
