All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, located about 2-1/2 miles north of the City of Greenville in a section known as Sans Souci, being known and designated as Lot 31 and a portion of Lot 30 of Block A as shown on a plat of said property being recorded in the R. M. C. Office for Greenville County in Plat Book A at Pages396 and 397 and re-recorded in Plat Book G at Page 160 and having, according to said plat, the following metes and bounds, to-wit:
