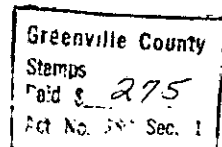

Office for Greenville County in Plat Book NMN at Page 74 and being known and designated as Lot No. 5, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 4 and 5 on Tigerville Road and proceeding thence S. 88-37 W., 100 feet along Tigerville Road; thence continuing along Tigerville Road S. 87-10 W., 50 feet to an iron pin at the joint front corner of Lots Nos. 5 and 6; thence N. 11-02 W., 198.7 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence N. 87-47 E., 150 feet to the joint rear corner of Lots Nos. 5 and 4; thence S. 10-54 E., 201.8 feet to the point of beginning.
