The grantor herein does hereby grant, sell and convey unto the grantees herein, their heirs, successors and assigns, an easement in and the right to use as means of ingress and egress all that certain tract of land described on a plat entitled Multiple Duples Housing for 0. B. Godfrey near Greenville, S. C., made by Carolina Engineering & Surveying Co., January 14, 1970, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book UUU, at Page 143, and having according to said plat the following metes and bounds, to-wit:
