the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Ruth L. Mansfield, her heirs and assigns, forever:

All my right, title and interest in and to all that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Cleveland Township, near River Falls, and having the following metes and bounds, to-wit;

BEGINNING on a small holly tree at the ford of a branch, Slatton's corner, and running thence up the branch N. 60 E. 1.80 chords to a sweetgum at mouth of another branch; thence N. 3 E. 4.04 chords up said branch to a sycamore; thence S. 68-1/2 W. 2.44 chords to a persimmon tree; thence S. 5 W. 3.24 chords to a stone; thence to the beginning corner, and containing 3/4 acres, more or less, and bounded by lands of the Estate of C. G. Drake, Slatton et al.

ALSO: All that other piece, parcel or lot of land lying and being in Cleveland Township, Greenville County, State of South Carolina, on the waters of Middle Saluda River near River Falls, South Carolina, and having the following metes and bounds, to-wit:

BEGINNING on a sycamore tree 3X on the east bank of a branch and running thence N. 3 E. 0.67 links to a poplar tree 3X, corner of M. B. Moore's (now Robert W. West); thence N. 70 W. 2.45 chords to a stone 3X; thence S. 7-1/2 E. 0.67 links to a persimmon tree 3X, corner of JP Jones (now Banks); thence with J. P. Jones (Banks) line N. 68-1/2 E. 2.44 chords to the beginning corner.

The above-described tracts are contiguous to each other and said property fronts on the northern side of Duckworth Road.
