unto ROBERT W. WHITTAKER, his heirs and assigns, forever:

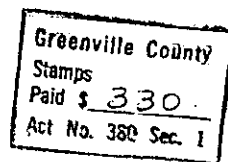

BEGINNING at an iron pin on the west side of Highway No. 20, at a point 187-1/2 feet northeast of Fred Tumblin's corner, and running thence along the line of said Highway N. 31-57 E. 187-1/2 feet to an iron pin, corner of Floyd J. Massey property; thence along the line of her property, N. 60 W. 257.5 feet to an iron pin; thence still with the line of her property, S. 29-1/4 W. 158-1/2 feet to an iron pin, rear corner of lot of J.
