ALL that certain tract of land, with the improvements thereon, situated in Fairview Township, County of Greenville, State of South Carolina, containing 65.75 acres in accordance with plat made by James P. Willis, dated September 27, 1921 for J. Russell Terry, Sr., and being more fully described in accordance with said plat, to-wit:

BEGINNING at a stone in the road, joint property corner of Grantor's property and that of Lewis C. Terry, and being the northwestern corner of Lewis C.
