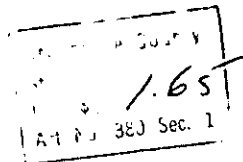


KNOW ALL MEN BY THESE PRESENTS, that N. Blair Bridle and Ether Lea Bridle
