the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto SETH W. SCRUGGS, HIS HEIRS AND ASSIGNS FOREVER:

ALL that tract or lot of land in Bates Township, Greenville County, State of South Carolina, being shown as Lot No. 1, on a plat of Section A, property of Seth W. Scruggs, by Webb Survey and Mapping Company, dated April 1969 and recorded in the RMC Office for Greenville County in Plat Book 4C at page 93 and being further described according to said plat to wit:

BEGINNING at an iron pin at the intersection of Maple Lane and Thomason Square and running thence with Maple Lane, N. 34-57 E. 54.2 feet to an iron pin; thence still with Maple Lane N. 51-17 E. 55 feet to an iron pin at the joint corners of Lots 1 and 2; thence with the line of Lot No. 2, N. 38-53 W. 112 feet to an iron pin; thence S. 45-30 W. 143.3 feet to an iron pin on Thomason Square; thence with Thomason Square, S. 56-13 E. 118.2 feet to an iron pin, being the point of beginning.
