Mauldin dated September, 1962 and prepared by C. C. Jones, Civil Engineer, and having, according to said plat, the following metes and bounds, to-wit:

Office for Greenville County in Plat Book EE, at Page 151, and running thence with the rear line of Lot No. 2, N. 22-40 E. 80.2 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 3, Mauldin Meadows Subdivision; and running thence S. 63-45 E. 156 feet, more or less, to a point; running thence S. 8-20 E. 65 feet to an iron pin; running thence S. 3-05 E. 32 feet to a point; running thence N. 63-45 W. 204 feet, more or less, to the point of beginning.
