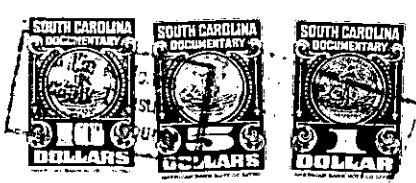
in consideration of Eight Thousand and No/100 (\$8,000.00) ----- Dollars,
