KNOW ALL MEN BY THESE PRESENTS, that I, Roger K. Randall

in consideration of One (\$1.00) love and affection for our father Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ralph M. Randall, his heirs and assigns, all my right, title and interest, the same being a 1/6 interest,

All that piece, parcel or lot of land in Gantt Township, Greenville County, state of South Carolina, being the rear portion of lots Nos. 18 & 19, lying on the east side of a Branch and portions of lots Nos. 25, 26 & 27 of Unit 1, according to plat made by W. J. Riddle, Surveyor, recorded in the RMC Office for Greenville County, in plat book M at page 3, and being more particularly described as follows:

Beginning at an iron pin at the southwest intersection of Pine Crest Drive and Catherine Avenue, which pin is 892.4 feet from the Augusta Road, and running thence along Catherine Avenue S. 0-33 E. approximately 188.5 feet to a branch; thence along said branch in a southerly direction to where said branch intersects the joint line of lots Nos. 19 and 20; thence in an easterly direction approximately 150 feet to the property owned by the City and County of Greenville formerly used as Army Air Base; thence along line of property owned by City and County of Greenville in a northeasterly direction approximately 360 feet to a point on the south side of Pine Crest Drive; thence N. 86-35 W. along the south side of Pine Crest Drive to the beginning corner.

The above described property is the same conveyed to Ralph M. Randall and Clarette Randall by J. H. Tilson and Dorothy Tilson by deed recorded in deed vol. 283 page 405 of the RMC Office for Greenville County. Subsequently Clarette Randall died in 1953 leaving as her sole heirs and distributees at law her husband, Ralph M. Randall, and two children, Roger K. Randall, the grantor herein, and Richard M. Randall.
