KNOW ALL MEN BY THESE PRESENTS, that I, Sara G. Forrester, of Greenville County

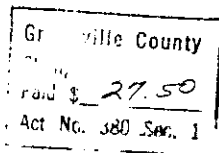
in consideration of Twenty-Five Thousand and No/100 (\$25,000.00)-----Dollars,

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Saluda Circle, being known and designated as Lot No. 143 on a plat of Section 3, Westcliffe, by Piedmont Engineers & Architects, dated June 3, 1965 revised December 24, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book JJJ at Pages 72 and 73 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Saluda Circle, joint front corner of Lots Nos. 143 and 144, and running thence with the joint line of said lots, N. 52-26 W. 199.5 feet to an iron pin, joint rear corner of said lots; thence with the rear of Lot No. 143 and Lot 141, N. 46-35 E. 75 feet to an iron pin, joint rear corner of Lots Nos. 142 and 143; thence with the joint line of said lots, N. 88-18 E. 160.8 feet to an iron pin on the western side of Saluda Circle, joint front corner of said lots; thence with said circle, following the curvature thereof, the following distances and chords: S. 0-55 E. 60 feet, S. 16-24 W. 85 feet, S. 43-15 W. 50 feet, to an iron pin, point of beginning; being the same conveyed to me by Lloyd W. Gilstrap by deed dated September 17, 1966 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 806 at Page 228.
