G. Proffitt, Inc., its successors and assigns forever, its undivided two-thirds (2/3) interest in and to:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Hunting Hollow Road, near the City of Greenville, S. C., being known and designated as Lot No, 106 on plat of Section I, Foxcroft, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Hunting Hollow Road said pin being the joint front corner of Lots 106 and 107 and running thence with the common line of said lots S 18-32 W 150 feet to a point in the center of a branch, the joint rear corner of Lots 106 and 107; thence down the branch with the center line thereof (the traverse line being S 26-20 E 112.6 feet) to a point in the center of said branch, the joint rear corner of Lots 105 and 106; thence with the common line of said lots N 37-5 E 207.7 feet to an iron pin on the southerly side of Hunting Hollow Road; thence with the southerly side of Hunting Hollow Road N 52-09 W 52.7 feet to an iron pin; thence continuing with said Road N 57-09 W 50 feet to an iron pin; thence continuing with said Road N 67-09 W 50 feet to an iron pin, the point of beginning.
