KNOW ALL MEN BY THESE PRESENTS, that Derrall Dunwoody -----

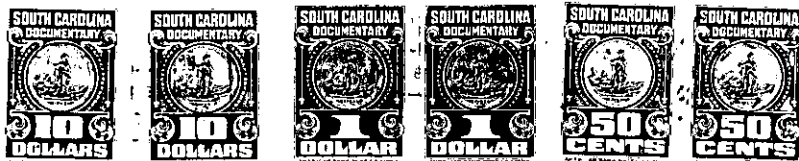
in consideration of Eleven Thousand Fifty and No/100 (\$11,050.00) ----- Dollars,
