All that lot of land in the County of Greenville, State of South Carolina, known as Lot 125 on plat of Piedmont Estates made by Dalton & Neves, dated December, 1944, recorded in the RMC office for Greenville County in Plat Book M at page 123 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Churchill Avenue at the joint front corner of Lots 125 and 126 and running thence S 24 W 175 feet to iron pin; thence S 66 E 60 feet to iron pin; thence N 24 E 175 feet to the point of beginning.

ALSO, all that lot of land situate in the County of Greenville, State of South Carolina, being known as Lot 124 on plat of Piedmont Estates made by Dalton & Neves, dated December, 1944, recorded in Plat Book M at page 123, located on Churchill Avenue, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Churchill Avenue at joint front corner of Lots 123 and 124 and running thence with joint line of said lots, S 24 W 175 feet to iron pin at joint rear corner of Lots 123 and 124; thence with the line of said lots, S 66 E 60 feet to iron pin at joint rear corner of lots 124 and 125; thence with line of Lot 125, N 24 E 175 feet to iron pin on Churchill Avenue; thence with said avenue N 66 W 60 feet to the point of beginning.
