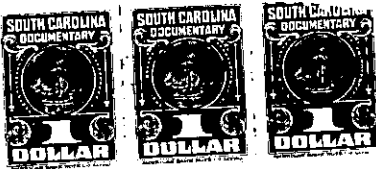
KNOW ALL MEN BY THESE PRESENTS, that JOHN F. CHANDLER, and CHARLES E. ROBINSON, JR.
