Whereas, on the 26th day of January, 1970, a deed was executed from Harold H. Hawkins & Ivory M. Hawkins to Harold R. Hawkins & Linda K. Hawkins; said deed was recorded in Deed Book 883, page 366 and the description was partially in error and this corrected deed is now being given.

KNOW ALL MEN BY THESE PRESENTS, that we, Harold H. Hawkins and Ivory M. Hawkins

in consideration of One and 00/100 (\$1.00), Love and Affection Dollars

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Harold R. Hawkins and Linda K. Hawkins, their heirs and assigns forever;

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina in the Paris Mountain Township, containing .574 acres of land and being a portion of Tract #10 on a plat of the property of the Estate of J. B. Hawkins, Jr., made by Dalton & Neves, January, 1949, and being known according to a plat prepared by Dalton & Neves on January 1, 1970, as Tract #10-B and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of other property owned by the Grantors herein and proceeding along a service road N. 28-00 E. 74.5 feet to a point; thence proceeding along the line of other property owned by the Grantees herein S. 35-25 E. 363.4 feet to an iron pin [deed S. 35 E. 422.3]; thence S. 53-14 W. 55 feet to an iron pin; thence N. 41-35 W. 322 feet to the point of beginning.

This deed is made subject to any restrictions and easements that may appear of record, on the recorded plat, or on the premises.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors, against every person whomsoever lawfully claiming or to claim the same or any part thereof.
