the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Adelene L. Freeman, her heirs and assigns,

All that piece, parcel or lot of land in the city of Greenville, county of Greenville, state of South Carolina, on the south side of Oregon Street, being a portion of lot No. 1, Block A, Kanatenah subdivision as shown on plat recorded in plat book F pages 131-132, and being more particularly described as follows:

Beginning at a point on the south side of Oregon Street, rear corner of Lot owned by Southside Baptist Church, and running thence with Oregon Street N. 65-35 E. 24 feet 8 inches more or less to corner of a brick building owned by Haskell H. Martin et al, which is also the corner of a 4 inch strip of land being conveyed this date by the grantor to Haskell H. Martin et al; thence along the line of said 4 inch strip of land S. 25-51 E. 55 feet to an iron pin in line of Lot No. 2; thence along the line of said lot S. 65-35 W. 24 ft 8 inches to an iron pin corner of property of Southside Baptist Church; thence with the line of said property N. 25-51 W. 55 feet to the beginning corner.
