N. Willis, Engineer, dated March 27, 1951, and recorded in the RMC Office for Greenville County, S. C., in Plat Book Z, page 148, and having according to a more recent plat thereof prepared by H. C. BEGINNING at an iron pin on the Northwestern side of Edwards Road at the corner of Lot No. 70 and property now or formerly owned by W. T. Bridwell, and running thence along the common line of said properties, N. 33-31 W. 160.5 feet to an iron pin; thence along the line of Lot No. 23, S. 47-02 W. 75.3 feet to an iron pin at the joint rear corners of Lots Nos. 69 and 70; thence running a new line through Lot No. 69, S. 30-29 E. 178.05 feet to an iron pin on Edwards Road; thence along the Northwestern side of Edwards Road, N. 37-13 E. 89.5 feet to an iron pin, the beginning corner.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the grantees agree to assume and pay, according to its terms, that certain note and mortgage given to Cameron-Brown Company, on which there is a balance due of \$14,565.61; said mortgage being recorded in Mortgages Volume 1061, Page 165.
