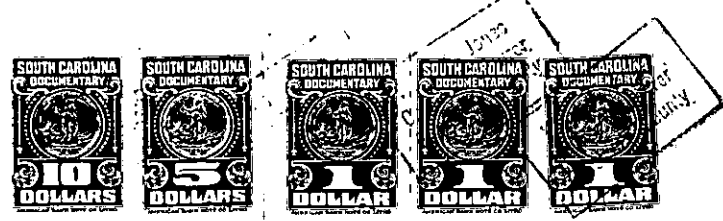
KNOW ALL MEN BY THESE PRESENTS, that We, MILLARD L. COLEMAN and NANCY J. COLEMAN,
