A TWO-THIRDS (2/3) INTEREST IN:
ALL that certain piece, parcel or lot of land situate, lying and being on the Southeastern side of Wade Hampton Boulevard (U.S. Highway No. 29) near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as the western one-half of Lot No. 19 as shown on plat entitled "Estate of Vance Edwards", dated December, 1946, prepared by Dalton & Neves, recorded in the R.M.C.
