KNOW ALL MEN BY THESE PRESENTS, that I, W.D. Shedd, OLLIE FARNSWORTH, M.C.

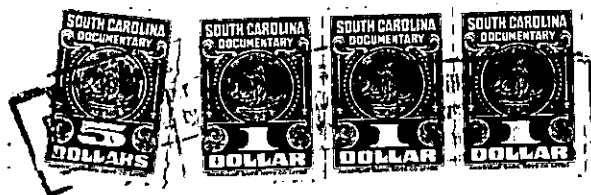
