CONTRACT FOR SALE OF REAL ESTATE

This Agreement entered into this the 1973day of June, 1972, by and between Robert L. Watkins, Jr., and Tamara A. Watkins, hereinafter designated as "Sellers" and C. Dan Joyner and Charles E. Upchurch, hereinafter designated "Purchasers",

WITNESSETH:

That the Seller agrees to sell, and the Purchaser agrees to buy,

upon the following terms, conditions, and the consideration hereinafter set forth, the following described real estate:

Parcel No. 1
