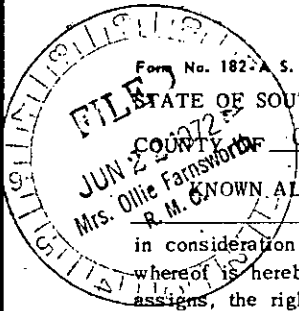

Circle Street in the Chick Springs Subdivision, Section No. 2, Taylors,  
S. C. and also shown as lots 20 through 32 inclusive on Plat of said  
Subdivision recorded in RMC Office in Plat Book PPP, Page 75.

and to construct, maintain and operate in, upon and through said premises, in a proper manner with poles, wires,  
guys, conduits, cables, transformers, and other necessary apparatus and appliances, overhead or underground  
lines for transmitting and distributing power by electricity, and for telephone purposes, together with the right  
at all times to enter said premises for the purpose of inspecting said lines and making necessary repairs and  
alterations thereon and additions thereto; together with the right at all times to cut away, or by other means to
