in consideration of One Dollar (\$1.00) Love and Affection Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Alice Boatwright Lane, her heirs and Assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, in that area formerly constituting the Town of West Greenville, but recently annexed to the City of Greenville, being the Western portion of Lot No. 12 of a subdivision known as Perry Avenue Annex, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book A, at page 878, and having, according to a plat of the property of the T. J. Seyle Estate prepared by Piedmont Engineering Service on March 16, 1950, the following metes and bounds, to wit:

BEGINNING at a point on the North side of Pendleton Street in the dividing line of Lots Nos. 11 and 12 of Perry Avenue Annex, which point is 80.48 feet from the East side of Perry Avenue, and running thence through the center of a party wall and continuing N. 13-15 E. 115.6 feet to an iron pin on the South side of Branwood Street; thence along the South side of Branwood Street S. 74.-20 E. 20.17 feet to a point; thence on a line through the approximate center of Lot No. 12 of Perry Avenue Annex and continuing through the center of a party wall, S. 13-15 W. 115.3 feet to a point on the North side of Pendleton Street; thence along the North side of Pendleton Street N. 76-51 W. 20.17 feet to the beginning corner.

This conveyance is made subject to any and all easements, rights of way and restrictions affecting said property or as shown on the recorded plat.

This being the same property conveyed to Ralph H. Peden by deed recorded in the RMC Office for Greenville County in Deed Book 414, at page 191. The said Ralph H. Peden died testate in Greenville County, leaving as his sole heir at law his widow, Marie M. Peden, the Grantor above named, as shown by the records of the Probate Court in Apt. 1105, File 4.

This same property is conveyed to the grantee as shown by deed recorded in Deed Book 945 at page 391, wherein Marie M. Peden conveyed to Albert D. Lane.
