ALL that certain piece, parcel and tract of land situate, lying and being on the northwest side of Georgia Road in the County of Greenville, State of South Carolina and being shown and designated as Tract No. 4 on Plat of property of Standing Springs, Section I, made by C. O. Riddle, R.L.S. on May 18, 1969 and recorded in the Greenville County RMC Office in Plat Book WW at Page 49, said tract containing 4.17 acres and having according to said Plat the following description:

BEGINNING at an iron pin in the center of Georgia Road joint front corner with Lots 4 and 5; thence with the line of Lot 5 N 50-09 W. 608.2 feet to an iron pin; thence N 39-51 E. 240 feet to an iron pin joint rear corner of Lots 3 and 4; thence with the line of Lot 3, S 50-09 E. 608.2 feet to a point in the center of Georgia Road; thence with the center of Georgia Road S 39-51 W. 240 feet to the point and place of beginning.

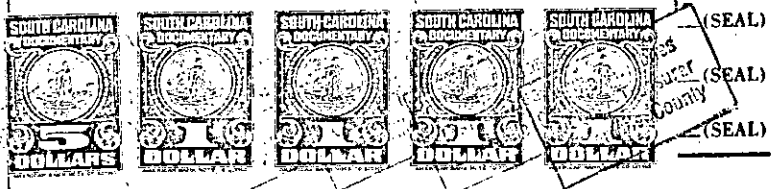
This conveyance is subject to protective covenants recorded in the RMC Office for Greenville County, South Carolina in Deed Book 869 at Page 105.
