

KNOW ALL MEN BY THESE PRESENTS, that I, Juanita S. Mackey

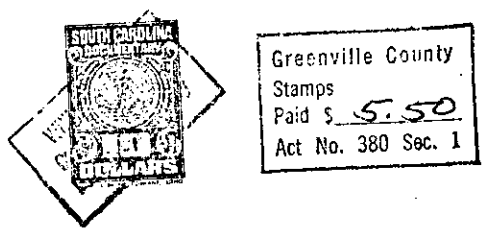
in consideration of Four Thousand, Nine Hundred Seventeen & 35/100 and Dollars,
