POWER OF ATTORNEY

I, the undersigned, Eller E. Ballew, being of sound and disposing mind but having recently suffered a stroke, and suffering ill health and partial physical disability which render me partially disabled to transact my ordinary business personal affairs, do hereby constitute and appoint my Attorney-in-Fact, Lillian B. Bradshaw, as my Attorney-in-Fact, and vest with her Power of Attorney to do in my name and on my behalf any and all of the following things:

To sign my name and otherwise execute any and all checks, bank drafts, deposit slips or other commercial paper as may be necessary for the general purposes of negotiating instruments made payable to me and depositing the same in my bank account, or removing the same therefrom or transferring the same therein; and further to sign my name or otherwise execute, witness, endorse, contract, approve, apply for, consent to or reject any and all contracts, deeds, applications, certificates, affidavits, promises, conditions or other undertakings as may be reasonably necessary to carry on my ordinary business and personal affairs as completely and effectually as if I were carrying them on in person;

To negotiate, bargain and sell and execute any bills of sale necessary to sell, transfer or otherwise alienate any personal property belonging to me;

To negotiate and deal with any real estate owned by me, and to sign deeds, mortgages, contracts or any and all other papers as may be necessary to transfer any interest in such real estate;

To execute any medical authorizations or other papers as may be needed by any doctors, nurses, hospitals or nursing homes in connection with my business or personal affairs; and to sign any and all government papers of whatsoever nature and description as may be necessary.

This Power of Attorney shall take effect immediately upon the execution of this instrument and shall remain in full force and effect from this date forward until terminated by me in writing of equal solemnity, or until otherwise terminated by operation of law. All signatures provided for and contemplated herein shall be styled as follows: "Eller E. Ballew, by Lillian B. Bradshaw, Attorney-In-Fact".

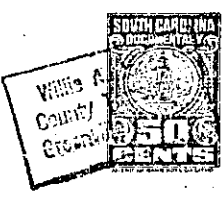
