in consideration of SIX THOUSAND and NO/100 (\$6,000.00) - - - - - Dollars,

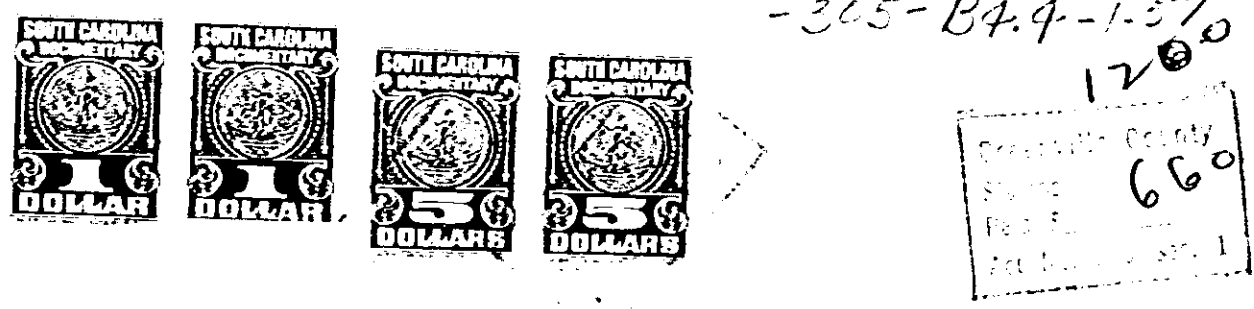

All that certain piece, parcel or lot of land lying and being on the southeasterly side of Club Circle, being known as Lot 40 of property of Greenville Motorboat Club, Inc., as shown on a plat recorded at Plat Book Y, page 21, in the RMC Office for Greenville County, South Carolina, and having according to said plat the following metes and bounds, to-wit:
