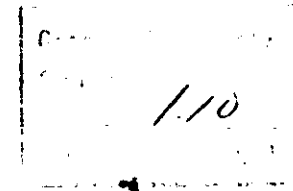

ALL that certain piece, parcel or lot of land, lying, being and situate on Tievoli Drive, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 1 in accordance with a plat made for Robert E. and Catherine T. Farrar, made by J. C. Hill, dated July 20, 1958, said plat recorded in Plat Book TT-17, County and State aforesaid, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Tievoli Drive, which iron pin is situate on the southwestern corner of Lot No. 1 and running thence N. 65-45 E., 335.3 feet to an iron pin; thence S. 24-15 E., 85 feet to an iron pin; thence S. 65-45 W., 341.1 feet to an iron pin; thence N. 20-W., 85 feet to an iron pin, the point of beginning.
