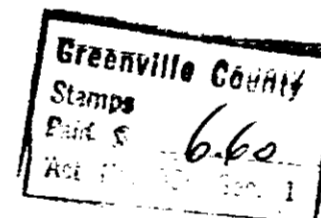
All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Devenger Road, near the City of Greenville, S. C., in Plat Book 4F, pages 2, 3 and 4, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Devenger Road, said pin being the joint front corner of Lots 16 and 17, and running thence with the common line of said lots S 3-49 E 165 feet to an iron pin, the joint rear corner of Lots 16 and 17; thence S 86-11 W 135 feet to an iron pin, the joint rear corner of Lots 17 and 18; thence with the common line of said lots N 3-49 W 165 feet to an iron pin on the southerly side of Devenger Road; thence with the southerly side of Devenger Road N 86-11 E 135 feet to an iron pin, the point of beginning.

This conveyance is subject to a 25-foot sewer easement and a 10-foot drainage easement, and to all other restrictions, setback lines, roadways, easements and rights of way, if any, affecting the above described property.
