in consideration of TWELVE HUNDRED AND NO/100 ----- (\$1200.00) ---Dollars,

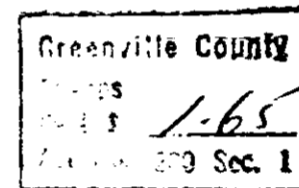
