ALL water lines, mains, valves and appurtenances installed and located in, under or along Lord Fairfax Drive, Fleetwood Drive and Cool Brook Drive, County of Greenville, State of South Carolina, including approximately 1,500 feet of 6 inch pipe, 1,190 feet of 3 inch pipe, 2,800 feet of 2 inch pipe, 150 feet of 1-1/2 inch pipe, 4 - 6 inch valves, 2 - 3 inch valves, 7 - 2 inch valves, 1 - 1-1/2 inch valve and 2 fire hydrants, and is shown on a drawing entitled "C. Douglas Wilson and Company to Commissioners of Public Works of the City of Greenville, S.C., March 4, 1974," attached hereto and made a part of this conveyance.
