BEGINNING at a point on the eastern side of South Brown Street 191.3 feet from the intersection of the said eastern side of South Brown Street with the southern side of East Washington Street and running thence S. 69-56 E. 103.10 feet to a point; thence N. 21-19 E. 80 feet to a point in the southern side of an unnamed 10 foot alley; thence with said alley S. 69-56 E. 46 feet to a point in the southern side of said alley; thence S. 21-19 W. 90 feet to a point; thence N. 69-56 W. 149.03 feet to a point on the eastern side of South Brown Street; thence with said eastern side of South Brown Street N. 20-56 E. 10 feet to the point of beginning. -500- 62-5-10
