the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

John S. Wright, Jr., his heirs and assigns forever:

All that certain piece, parcel, or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 204 of a subdivision known as Pebble Creek, Phase I as shown on plat thereof prepared by Enwright Associates, Engineers, dated October 1973, and recorded in the R. M. C. Office for Greenville County in Plat Book 5-D at pages 1-5 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Pebble Creek Drive at the joint front corner of Lots 204 and 205 and running thence along the eastern side of said Pebble Creek Drive, N. 20-35 W. 120 feet to an iron pin at the joint front corner of Lots 203 and 204; thence with the common line of said lots, N. 68-48 E. 154.64 feet to an iron pin at the joint rear corner of said lots; running thence along the rear line of Lot 204, S. 29-39 E. 123.36 feet to an iron pin at the joint rear corner of Lots 204 and 205; thence with the common line of said lots, S. 69-28 W. 174.06 feet to an iron pin at the joint front corner of said lots, the point of beginning.

This conveyance is subject to restrictions and covenants being recorded in the R. M. C. Office for Greenville County in Deed Vol. 991 at Page 10 as well as any other restrictions, rights-of-way or easements that appear of record, on the plat referred to above or as shown on the premises.
