WARRANTY DEED
(Jointly for Life With Remainder to Survivor)
(FOR PURCHASE)

THIS WARRANTY DEED, made this 11th day of October, 19 74,
between IMPERIAL CONSTRUCTION CO., INC.
of GREENVILLE County, State of SOUTH CAROLINA, Grantor(s);
and GENE A MILLER AND MARGARET S. MILLER
of GREENVILLE County, State of SOUTH CAROLINA, Grantee(s);

WITNESSETH: That the said grantor(s) for and in consideration of the sum of SEVENTEEN THOUSAND FOUR
HUNDRED AND NO/100 Dollars (\$ 17,400.00),

to it in hand paid by the Grantee(s), the receipt whereof is hereby acknowledged, has
granted, bargained, sold and conveyed and by these presents do es hereby grant, bargain,
sell and convey unto the said Grantee(s) for and during their joint lives and upon the death of either of them, then to the
survivor of them, his or her heirs and assigns forever in fee simple, together with every contingent remainder and right of

reversion, the following described land, lying and being in the County of Greenville,
State of South Carolina, to-wit:

ALL that certain piece, parcel or lot of land in the State of South
Carolina, County of Greenville, Town of Fountain Inn, being known
and designated as Lot No. 81 on a Plat of Kings Court, prepared by
R. B. Bruce, Surveyor, dated Sept. 4, 1973, and recorded in the
RMC Office for Greenville County in Plat Book 4X at page 78 and
having, according to said plat, the following metes and bounds,
to wit:

BEGINNING at an iron pin on the southwesterly side of North Kings
Drive, joint front corner of Lots No. 81 and 82 and running thence
with the line of Lot No. 82, S. 14-22 W., 157.1 feet to an iron pin;
thence N. 78-25 W., 80 feet to an iron pin; thence with the line of
Lot No. 80, N. 14-21 E., 163.6 feet to an iron pin on the south-

Drive, S. 73-49 E., 80 feet to the point of beginning.
