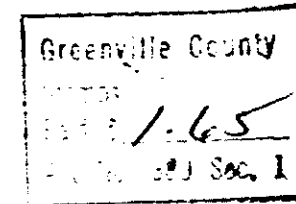
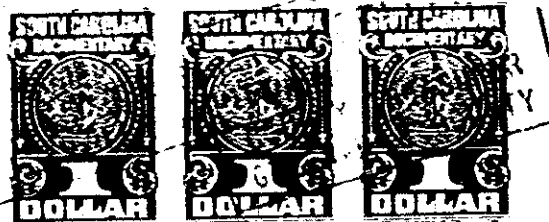
ROBERT C. CHILDS, his heirs and assigns:
