NOW, KNOW ALL MEN BY THESE PRESENTS, that Jannie Burns, M. A. Burns, Bessie B. Knight, Rosa Lee B. Fleming, Mae B. McAlhaney, Julius B. Burns, Essie B. Brady, Christine B. Johnson and Pinckney Burns, Jr. in consideration of One and No/100 (\$1.00) Dollar and the division of real estate, the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Frances B. Griswold:
