Cunningham, deceased, (the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Bank of Greer, Trustee for Nelle Cunningham Black under the Will of Jesse C. Cunningham, deceased, its Successors and Assigns forever:

All my right, title and interest in and to all that certain piece, parcel or lot of land situate, lying and being on the north side of Victoria Street in the Town of Greer, Chick Springs Township, Greenville County, State of South Carolina, and having the following courses and distances, to-wit:

BEGINNING at a pin on the north side of Victoria Street, now O. M. Mitchell's corner, and runs thence east with said street about 90 feet to an alley between said lot and Bank of Greer and J. C. Cunningham property; thence north with said alley about 75 feet to J. C. Cunningham's line (formerly W. E. and R. M. Waldrop); thence west with said line about 90 feet to O. M. Mitchell's corner; thence south with Mitchell's line about 75 feet to the beginning corner.
